Boosting accessibility is as important as fighting any other form of discrimination. Many times the City forgets to see the needs of those with various disabilities. I see you and I will continue to be your advocate.

In what ways will you use City resources to create housing options that are affordable AND accessible for Cincinnatians with disabilities? *

I will continue to champion visitable incentives, along with targeting a portion of our housing dollars to fully accessible projects and renovations. Further, we need to put more pressure on our city administration to follow the ADA. Lastly, we should work with seniors to provide low-cost options to allow for ramps and other accessibility improvements to their homes to further aging in place.

What are your goals for increasing affordable and accessible transportation options for Cincinnatians with disabilities? *

I continue to be a champion of an expanded Metro bus system. Additionally, we need to raise the bar for ACCESS riders and ensure that even once they are off the bus, sidewalks are clear and accessible for all users.

In what ways will your office work with the Cincinnati Accessibility Board of Advisors (CABA) to increase ADA compliance in businesses across the city? *

I believe CABA should make frequent presentations directly to council and the Administration on the areas we are doing well, and the areas we aren't. Additionally, CABA can be a part of the review process for major developments and major law changes to ensure there is no negative impact to accessibility.

How can the City of Cincinnati be more inclusive of people with disabilities and their families? *

The City of Cincinnati, for the last 10 years, has been a beacon of hope for anyone experiencing discrimination. We have made dramatic improvements from where we were two decades ago on these issues. Yet, we aren't active enough in our recognition of the challenges and discrimination, intentional or accidental, faced by Cincinnatians with disabilities. The City can highlight this inclusiveness through programming efforts at Rec Centers, parks, our hiring and employment practices and our representation on city boards and commissions.
