Any changes that are being made to public transportation must be down with disabled Cincinnatians in mind. We cannot spend hundreds of millions of dollars on transportation options that are not available to everyone.

In what ways will your office work with the Cincinnati Accessibility Board of Advisors (CABA) to increase ADA compliance in businesses across the city? \*

Discussions with the CABA have to be integral to all of our decisions about constructions and renovations in the city. We need the insight from the CABA to ensure not only that we are ADA compliant but also to ensure that our choices lead to a more accessible city.

How can the City of Cincinnati be more inclusive of people with disabilities and their families? \*

The City of Cincinnati can be more inclusive of people of disabilities by not overlooking them in our decision making process. By simply asking "how will this decision impact the disabled community of Cincinnati" and bringing them and their needs into the discussion we are making our city more inclusive.
